Likewise, the cookies used on this website used on this website do not collect users' personal data (names, surnames, first names, surnames and (names, surnames, address, bank details or any other). other).

In addition, in order to improve your privacy, the IP address has been encrypted, keeping a record of them.

IP address encryption, keeping a record of these addresses, so that the information therefore, the information obtained by means of the cookie service used is purely statistical and totally service is exclusively statistical and totally anonymous. anonymous.

## 2. TYPES OF COOKIES USED

The cookies used are:

1. Depending on the entity that manages them:
  - o First-party cookies: These are cookies that are sent to the user's terminal equipment user's terminal equipment from a computer or domain managed by the application and from which the service requested by the user is provided. service requested by the user.
  - o Third-party cookies: These are cookies that are sent to the user's terminal equipment to the user's terminal equipment from equipment or domains managed or not by the group, with a third party being the one that processes the data obtained through the cookies.
  
2. According to the length of time they remain activated on the user's terminal equipment:
  - o Session cookies: these are cookies designed to collect and store data while the user accesses a website or application. a website or application. They are used to store information that only needs to be kept for the provision of the service the service requested by the user on a single occasion.
  - o Persistent cookies: These are cookies in which the data continue to be stored in the terminal and can be accessed and processed for a can be accessed and processed during a period of time defined by the group, which can range from a few minutes to several years.
  
3. According to the purpose for which the data are processed obtained through cookies:
  - o Technical cookies: These are those that allow the user to browsing through a web page, platform or application and the use of the different application and the use of the different options or services that exist therein.
  - o Personalisation cookies: These are those that allow the user to access the service with certain characteristics. the user to access the service with some predefined predefined general characteristics, depending on a series of criteria in the user's of criteria in the user's terminal (for example, the language, the type of language, the type of browser through which the service is accessed, the regional service, the regional configuration from which the service is accessed, etc.).
  - o Analysis Cookies: These are those that allow the monitoring and analysis of user behaviour of the websites to which they are linked. The information collected by means of this type of cookie is used to measure the activity of the websites, application or platform and for the elaboration of browsing profiles of the users of these browsing profiles of the users of said sites, with the aim of improvements based on the analysis of the data on the use of the service by users. data on the use made by users of the service.
  
  - o Advertising Cookies: These are those that allow the most effective

management, in the most efficient way possible, of the advertising spaces that, where appropriate, have been included on a website, application or website, application or platform from which the requested service is provided, based on requested service is provided, based on criteria such as the edited content or the content edited or the frequency at which the advertisements are shown. advertisements are shown. This website does not integrate cookies of this type within the web services provided to the user.

o Behavioural advertising cookies: These are those that allow the management, in the most efficient way possible, of the advertising spaces that, in your advertising spaces that, where appropriate, have been included in a web page, application or platform. on a website, application or platform from which the requested service is the requested service is provided. These cookies store information on user behaviour obtained through the continuous observation of their browsing habits, which allows a profile to be browsing habits, which makes it possible to develop a specific profile to display advertising based on the same. This website does not integrate cookies of this type within the web services web services provided to the user.
